

Information & Clarification Text Within The Scope of Personal Data Protection Law (PDPL)

Information Regarding Personal Data Protection Law

Personal Data Protection Law with no.6698 has come into effect on April 7th 2016 by being published in Official Gazette.

The aim of the law is to protect rights & freedom of individuals especially the right of privacy while processing personal data and to regulate procedures & principles and responsibilities of real or legal entities who are to process personal data.

First of all, we want to express to our clients, suppliers, employees and employee candidates that your personal data will be kept and processed in accordance with Personal Data Protection Law.

Data Hidrolik is gathering personal data from person groups related with continuity of sold products & services and processing these data within legal boundaries.

According to the Law, personal data means all information about identified or identifiable real person. Data Hidrolik holds personal data within its activities about related persons like identification information, purchase/sale information, contact information, and personnel information (about employees) and other information about you.

Your personal data, data of our clients who are directly in touch with our company, data of our employees, our suppliers, and data of employees of our suppliers given by themselves or their companies with their consent, are processed by Data Hidrolik in accordance with legislation provisions.

The reason(s) for processing your personal data may be; purchasing a product or service from our company, making a sale, being an employee or employee candidate for our company and/or fulfilling any similar agreements made with our company; to be in conformity with information storage, reporting, informing regulations foreseen by management; offering products or services requested by yourself, to increase contact/service quality and to know our clients better within the data you allow to be processed, to ensure correct product availability, or to use it to ensure the continuity of trade relation.

All the information you may give to our company is processed in accordance with the related legislation and/or in scope of the consent given by you.

Data Hidrolik puts great importance in keeping customer information confidential, employees staying confidential and sharing the information with third persons within boundaries set with the Law.

Your personal data can only be transferred to official authorities and local real or legal entities with terms & conditions set by the Law.

However, because of our legal responsibilities, personal data are shared only with courts and other public enterprises. Moreover, in order to provide the services we promised and to be able to control the quality of given services, personal data may be transferred to contractual third parties.

To avoid any violation of rights during data transfer required technical and legal precautions are taken. However, from the violations occurring because of receiving third party's data protection policies and in the risk area which is responsibility of third party, Data Hidrolik is not responsible.

Any real or legal entities who shared personal data with our company has the right to;

- Learn whether their personal data is processed or not.
- Request information regarding processed personal data if any.
- Learn the aim of processing their personal data and whether these data is used properly.
- Learn the third parties personal data is shared with, to request correction of mistakes in their personal data and if they are transferred, to request correction of mistakes in their personal data in third parties.
- In case of reasons for processing their personal data is disappeared request the removal, destruction or anonymization of their personal data, and if their data is transferred, to request forwarding this request to third party.
- Object to any negative results regarding themselves as a result of processed data.
- Request compensation in accordance with the law if any damage is done because of illegal data processing.
